B. Street Tree Planting Bid

Jim Heines updated the committee on the tree bids that came in. Several of the types of trees on the original list created by the committee were priced much higher than anticipated and therefore need to be removed from the list. Jim Heines modified the list for the street tree program for Fall 2017. HEB Committee to create tree bid list for next year and provide to the Public Works Department.

C. MDC Grant for Tree Planting

General discussion on grant uses. Jim Heines clarified that the current grant money they have does not allow for the monies to be allocated for the removal and replacement of trees.

D. Japanese Knotweed - KnowKnotweed.org

Jim Heines provided information from a recent conference he attended that discussed the invasive species Japanese Knotweed, which is currently in the Northeast United States. Jim provided handouts with pictures of this invasive species and there was general discussion on how to prevent the species from spreading in Missouri as well as informing the public on this topic.
